# **TENANT FEES SCHEDULE**

## **Tenant Request for Early Termination**

If a tenant decides to terminate their fixed-term tenancy before its expiration date, they will be responsible for covering the expenses incurred by the landlord in finding a new tenant. Additionally, tenants will remain accountable for paying the rent, council tax, and utility bills as per the tenancy agreement's terms until the start of the new tenancy or the end of the fixed term, whichever comes first. The tenant will be obligated to pay the landlord's costs for re-letting, which will be either 50% of one calendar month's rent plus VAT or £500 plus VAT (£600 including VAT), whichever amount is higher. The payment should be made to lqbal Homes before the start of the remarketing process.

## Rent Arrears / Returned Payments

In the event that the tenant fails to pay their rent, they will be responsible for a fee of  $\pounds 25 + VAT$  ( $\pounds 30$  inc VAT) for each written correspondence, telephone call, or email made by the agent in requesting payment. This fee covers the costs incurred by the agent in pursuing the outstanding rent. The payment should be made to Iqbal Homes.

## Missed Appointments

If the tenant fails to attend or allows access to a pre-arranged appointment with the agent, a missed appointment charge will be applied. This fee is for the agent's time and will be £25 + VAT (£30 inc VAT) per missed appointment. It will include any pre-arranged routine inspections and any additional costs incurred, such as contractor charges.

## Purposeful or Avoidable Property Damage

If the tenant causes avoidable or intentional damage to the landlord's property, they will be responsible for paying the complete cost of repairing any damage to the property (as per the contractor's invoice), along with the agent's expenses for obtaining quotes, arranging contractors, arranging permission, and any related travel costs at  $\pounds 50 + VAT$  ( $\pounds 60$  inc VAT), which must be paid to lqbal Homes.

## Emergency / Out of Hours Call Charges


If a tenant's purposeful or otherwise avoidable actions require the agent or nominated contractor to attend the property outside of normal working hours, the tenant will be responsible for paying the agent's time to resolve the situation, which will be charged at £50 + VAT (£60 inc VAT) per
